Data We Collect

- When you visit the website: IP address, browser type, pages visited, and cookies
- When you book a place at a Discover Activity Camp or Discover Camp: Your name, contact details, child's name and age, emergency contact information, medical or dietary needs
- When you sign up for our newsletter: Your name and email address
- When you contact us via a form or email: Any personal data you choose to share

How We Use Your Data

We use your personal information for the following purposes:

- To process and manage bookings for Discover Activity Camps and Discover Camps
- To communicate with you about your booking

- To send you updates about Discover Activity Camps holiday activities and events
- To communicate with you about relevant events or open days at schools within Wishford Schools (Group) Ltd
- To improve our website and understand visitor behaviour
- To comply with legal or safeguarding obligations

Marketing and Communications

If you opt-in to receive a newsletter or marketing communications, we will use your name and email address to keep you informed about Discover Activity Camps, Discover Camps and related events. You can unsubscribe at any time using the link provided in our emails, or by contacting us directly.

Sharing Your Data

We may share your data for the following purposes:

- With individual schools within Wishford Schools (Group) Ltd for communications about events such as school open days
- With third-party service providers who support our booking and communication systems (e.g. booking platforms, email tools)
- When required by law or to protect the welfare of children attending our camps

We do not sell or share your data with third parties for unrelated marketing purposes.

How Long We Keep Your Data

We only keep your personal information for as long as necessary for the purposes described above, or as required by law (e.g. for safeguarding or financial record-keeping).

Your Rights

Under the UK GDPR, you have the right to:

- Access your personal data
- Request correction or deletion of your data
- Object to or restrict processing of your data
- Withdraw your consent (for marketing)
- Lodge a complaint with the Information Commissioner's Office (ICO)
